5. <u>DISCUSS & CONSIDER APPROVING MEMORANDUM OF UNDERSTANDING WITH OPERATING ENGINEERS</u>

Mayor Ervin stated this memorandum is a letter stating the Thurman can go back in to the union if he does not hold the Superintendent of Operations position anymore. Ervin noted this is just a standard letter with the union employees.
